**Acceptable Hazardous Waste Materials:**

- Thinners and solvents
- Propane cylinders  
(limit of 5 large (>1lb.) cylinders, limit of 10 1lb. cylinders)
- Pesticides, herbicides, lawn/garden chemicals
- Cleaners, detergents and poisons
- Light ballasts (remove from light fixture)
- Fluorescent tubes
- Ammunition
- Pool and spa chemicals
- Art and hobby chemicals
- Gas/diesel/fuels
- Batteries (all types and applications)
- Fireworks/flares
- Items containing mercury



**HAZARDOUS DISPOSAL  
IS FREE OF CHARGE**

**Items NOT accepted:**

- ⊘ Household garbage / trash
- ⊘ Asbestos
- ⊘ Ethyl/Ether
- ⊘ Unwanted/Unused Medicines or Pharmaceuticals
- ⊘ Liquids in containers **larger than 5 gallons**
- ⊘ More than 25 gallons of liquids-per household (excludes paint and oil)
- ⊘ Radioactive Materials
- ⊘ Vehicles

**Bring products in original container and Secure**

**Your Load** *Please note: Containers used to transport liquids for disposal will not be returned. This streamlines the process and keeps everything running smoothly, minimizing wait times. Thank you for your understanding!*

***RECYCLE these items at the Transfer Station (during business hours):***

- ✓ Latex and Acrylic Paint, Oil-Based Paint
- ✓ Enamels, Stains, Lacquers, Shellacs, Varnishes and Primers
- ✓ Used Motor Oil and Antifreeze
- ✓ Electronics-TV's, computers, monitors, etc.
- ✓ MEDICAL SHARPS: must be in a sealed, OSHA approved, puncture-proof containers (available at the Transfer Station scale house).

For All OTHER MATERIALS including materials from Very Small Quantity Generators (VSQGs, <220 lbs./mo.) and liquids in containers larger than 5 gallons, **call Marc Winkler of ACT Enviro (916-693-4496)** at least 2 weeks prior to the event for appointment.
