SERGEANT'S CORNER

Responsibility of Dog Owners. In recent weeks we have investigated several dog complaints. A few have been barking dogs that have barked for extended periods of time. Several others have been aggressive dogs that have either approached people on public right of ways or actually bit individuals who were merely walking on public right of ways. Columbia City does have a city ordinance that requires you to maintain control of your animal at all times. This ordinance can be viewed at the city web page under the tab of (City Ordinances and Charter) Chapter 4-Offenses, 4-2 Animal Control. This can carry a fine of \$500 for each violation. So please, be a responsible pet owner and protect your dog and neighborhood by maintaining control of your pets. If you have any questions or concerns about this topic please contact the Police Department at the non-emergency number, 503-397-1521, or City Hall, 503-397-4010.

During the month of October, we have completed 9 new written reports and responded to the following calls: 5 audible alarms, 4 assist persons, 1 civil call, 1 disturbance/fight, 9 follow up calls, 1 fraud, 3 harassment/ threats, 1 juvenile custody dispute, 1 juvenile runaway, 1 missing juvenile, 2 motorist assists, 1 missing person, 119 premise checks, 5 suspicious circumstances, 1 suspicious person, 3 suspicious vehicles, 1 traffic crash, 19 traffic stops and 2 welfare checks. In total we handled 202 activities for the month of October, 2021.

DEAR DOG OWNERS QUIT LETTING YOUR DOGS RUN LOOSE


"She's big but she's friendly," you say about your unleashed dog when you see me freeze. And in an instant, the disregarded leash law is no longer the problem — my palpable fear is. If I stop to change

course when I see a loose dog, I'm seen as a doghating jerk. It's impossible to explain my fear to every stranger with a dangling leash, there is no time to convey my worry and its origins. And, even if there were, no one thinks their dog would ever be the one to unexpectedly go off on a child or adult or someone else's pet. But I do wish that you would consider how not leashing your pet impacts me and lots of other people.

Even if you're sure your dog wouldn't come unhinged, please think about how loose dogs — friendly or not — can trigger fear and trauma in those who have been attacked, chased, or cornered in the past.

Many people have had multiple scary encounters with unleashed dogs — most with dogs that were with or near their humans or their homes. Most of those dog

owners said the same thing: "My dog has never behaved like that before!" or "My dog loves kids!" Neither comment can erase the experience and both serve to affirm the reality that dogs are animals and sometimes unpredictable.



People need to consider the importance of leash laws and calculate the risks of not following them. It is hard for most people to state their needs or make reasonable requests to strangers. It isn't personal. Their wish would be for their fear not to be someone else's irritation.

Please considered the safety of your pet, people and other pets walking near you or your home and keep your pets leashed at all times.




