ST. HELENS SCHOOL DISTRICT WEEKEND FOOD PROGRAM NEEDS PEANUT BUTTER

The St. Helens School District Backpack Weekend Food Program is conducting a peanut butter drive during November. The mission of the Program is to

help ensure that no child goes hungry. Those in need are given a weekly bag on Friday with food for two breakfasts, two



lunches, two dinners, plus fruits and a snack. The desire is to send peanut butter once a month as a good protein source. All food is purchased with funds from individuals and business donations, and food

bags are prepared by volunteers from the First Methodist Church, the St. Helens Lions Club and other local groups.

The number of bags distributed per week has increased from about 50 last year to about 235 this year. Because of this big jump and the increase of the cost of food, the program is in urgent need of donations of peanut butter. They would greatly appreciate 16 ounce PLASTIC jars of peanut butter. City Hall will be a drop off site through the end of the month.

VIEW INTO THE PAST – The Caples Family Part One By Mark Stevens

I am sure many readers are familiar with the name



Caples and have visited or driven by the Caples Museum on Second Street that was built by Dr. Charles Caples.

But did you know

that not one, but seven Caples families moved and settled in the Northwest.

The most familiar family is Joseph Caples along with his children Charles, Hezekiah and Joanna. Joseph, who was a widower, and his family left St. Joseph Missouri on the Cornelius Gilliam wagon train in May of 1844 and reached the Marcus Whitman Mission near present day Walla Walla in December of 1844. Joseph and family continued on to Salem in early 1845 and wintered over there before traveling to Clatsop County where Joseph was a sheriff there from 1846 to 1847. Joseph applied for a Donation Land Claim (DLC) in what was to become Columbia City and soon built a cabin along the banks of the Columbia River on December 1.

Joseph's brother Jacob Green Caples joined Joseph in September of 1850 and applied for a DLC at the north end of Columbia City on December 12, 1850.

By March of 1860 Jacob had sold off all of his property and disappears. Cousin Don Caples mentions that he had heard that one of Joseph's brothers had drowned in the river at Columbia City and was buried at the Masonic Cemetery but there are no records to substantiate this.

Another of Joseph's brothers, William Caples, came to Oregon in 1849 and filed for a DLC in what was to become St. Johns on November 26, 1850. William was a prominent Physician in St. Johns.

A third brother of Joseph's was Kenzie Caples who came to Oregon in 1850 and filed for a DLC near Woodland, Washington. Kenzie fell off a dock in St. Helens in 1853 and drowned and is buried at the Masonic cemetery. Could this be the brother that Don Caples mentioned?

Joseph's sister Mary was married to a Phillip Laffer and they immigrated to Oregon and filed for a DLC near Scappoose on August 20, 1852.

Two of Joseph's cousins, Henry Laffer Caples and John Fletcher Caples also came to the Northwest. Henry took up a DLC at Woodland on December 25, 1852 and by 1865 was living in Portland. John F Caples was a soldier in the civil war and immigrated to Portland in 1865. All were prominent lawyers.

In the next installment I will go more in depth on the early years of Joseph Caples and his family.
