PROPOSED FIRE STATION

The following are pertinent facts:

The population of Columbia County is increasing, and as a result, so will the service demands of the CRF&R Fire District. Currently, Columbia City equals approximately 7% of CRF&R's call volume. However, CRF&R provides 100% of our ambulance and fire services.

In order to maintain/improve response times, the CRF&R is going to build another fire station; the question is where? One of CRF&R's choices is Columbia City and to do so, the CRF&R plans, through grants, to build and furnish a new fire station without an extra levy on Columbia County taxpayers.

Preliminary CRF&R projections include the new station to need, at a minimum, one fire truck, one ambulance, a water tender truck, and full time (24/7/365) firefighters/paramedics assigned to this proposed station. This will be the case regardless of where the new station is located.

The one thing CRF&R needs is land, approximately 1.25 acres, to build on. Grants, historically, will not be awarded to projects that don't already have ownership of their land. An exhaustive search has been conducted for possible sites within Columbia City to potentially build this fire station and, after due diligence has been completed, it has been determined that the only viable option within the city limits where the City has control over the land/property needed is a portion of Bundy Park, which totals a little over 3 acres.

Columbia City owns more parks than we can properly care for. The city can legally donate land to another municipal organization. If the new owner ceases to need or use that property it reverts back to Columbia City.

Last, but not least - this is a three to five year project. The sooner it starts the sooner it's finished in order to better provide for ambulance and fire services within our community through quicker response times.

COMMITTEE VACANCIES



The City currently has vacancies on the following Committees or Commissions.

Applications for any of these positions may be picked up at City Hall, or may be found on the City's website at www.columbia-city.org – under Doing Business, Public Service Forms.

Budget. The Budget Committee meets at least once annually to review the proposed budget, hear public testimony and approve a budget for submission to the City Council. Budget Committee terms are for a period of three years. Applicants must reside within the City.

Hazard Mitigation. The Hazard Mitigation Committee monitors and documents progress made on the implementation of the City Hazard Mitigation Plan, reviews actions taken in response to disasters or emergencies that occur, makes recommendations for new projects or revises action items and discusses implementation as problems arise. The committee usually meets quarterly.

Planning Commission. The Planning Commission currently has two open positions. Terms are for four years and applicants must reside within the City or the City's Urban Growth Boundary. The Planning Commission meets at 6:30 pm on the third Tuesday of each month if there are topics to discuss.

High Water. With the recent nice weather and higher temperatures the Columbia River is experiencing higher water levels than in the recent past. If you have been to Trestle Beach or Pixie Park you may have noticed there is not much beach available for use. Please be cautious when using the parks. This high water can be very dangerous with continuously changing currents, floating debris, ship and boating waves, and ever changing bottom contours. If you are going to swim in these conditions or allow children in the water, it is always recommended that everyone use a life jacket or flotation device. We encourage everyone to get out and enjoy your local area, but always keep safety in mind.

CODE ENFORCEMENT REMINDER

Keep grass and weeds cut: Between April 15th and September 30th weeds and grass cannot exceed 10 inches in height within the City limits. An owner or person in charge of property shall cut down or destroy grass, shrubbery, brush, bushes, weeds or noxious vegetation as often as needed to prevent them from becoming unsightly, from becoming a fire hazard, or, in case of weeds or other noxious vegetation, from maturing or going to seed.
