PLANNING COMMISSION NEWS PUBLIC HEARINGS SCHEDULED

The Columbia City Planning Commission will hold a public hearing on Tuesday, December 17, 2024, at 6:30 p.m. to consider proposed changes to the City's Land Use and Development Code (Title 7). These amendments are part of the City's efforts to make regulations more useable for residents, developers and City staff by correcting errors, eliminating text ambiguities and redundancies, and clarifying code text. Amendments are throughout the existing code. including changes to standards related to accessory dwelling units (ADUs) and manufactured homes consistent with state law. They also include the removal of standards that are not clear and objective from chapter 7.120 Site Development Review and changes recommended by the DLCD Oregon State NFIP review to chapter 7.75 Flood Hazard Overlay. Note that the City is not implementing changes to this chapter based on the FEMA Pre-Implementation Compliance Measures for Endangered Species Act (ESA) at this time.

The City Council may consider the Planning Commission recommendation regarding this proposal

at a public hearing on January 16, 2025, at 6:00 p.m. Both hearings will take place in the Council Chambers of City Hall in Columbia City at 1840 Second Street.

Interested persons are invited to attend any of the public hearings and present oral and/or written testimony. If you would like to comment but cannot participate in one of the hearings, you may submit written testimony. It must be submitted to City Hall no later than 2:00 p.m. on December 17 for the evening Planning Commission hearing or no later than 2:00 p.m. on January 16 for the evening City Council Direct written comments to Office Supervisor, Helen Johnson, at PO Box 189, 1840 Second Street, Columbia City, OR 97018, or hjohnson@columbia-city.org. Failure to raise an issue with sufficient specificity to afford the decision makers an opportunity to respond to the issue precludes appeal on that issue. Only comments on applicable approval criteria are considered relevant evidence.

A complete copy of the proposal record, including the staff report, staff findings and staff recommendation will be available at City Hall for viewing seven (7) days prior to each public hearing.

KEEPING CATS INDOORS

According to the National Audubon Society and the Seattle Audubon Society, predation by cats is a leading threat to birds and wildlife in urban and suburban areas. By keeping your cats indoors, you help protect local wildlife, and you help your cat lead a longer, healthier life.

- Outdoor cats (both companion animals and strays) kill millions of songbirds and small mammals per year.
- Cats transmit diseases to wildlife.
- Even well fed cats hunt and kill wildlife.
- ✓ Indoor cats live three times longer, on average, than outdoor cats.

PUBLIC WORKS COMPLETED WATER SERVICE LINE INVENTORY FOR LEAD & COPPER RULE REVISION

The Columbia City Municipal Waterworks inventoried all water service lines in the system and determined there were no lead service lines. This determination was made using construction records, construction dates, maintenance and replacement records, and visual inspection.

The Lead and Copper Rule applies to all Community (CWS) and Non-Transient (NTNC) public water systems. EPA adopted revisions to the Lead and Copper Rule in 2021 that include a requirement for public water systems to conduct inventories of service lines and to identify service line material type. The intent of the service line inventory requirement is to identify those service lines made of lead so that they can be scheduled for removal and replacement.

The inventory of our service lines has been submitted to, and approved by, the Oregon Health Authority (OHA). Since no lead service lines were found in our system, no further action is required. A VIEW INTO THE PAST Roughing It

Try to imagine if you will, a party of 16 plus individuals making the journey from Columbia City to the base of Mt. St. Helens for a planned camping trip for a month. Now imagine doing this in 1897 (127 years ago) by



horse and buggy accompanied by provision wagons on primitive roads. This is exactly what the Caples family did, accompanied by family and friends numerous times over the years.

Below is an article from the July 20, 1897 Oregon Mist

Jolly Campers - Fred & Miss Willie Caples of Columbia City, Geo. M. McBride & L. Kelly of Oregon City, Boyd Richardson of Salem and Miss Dell Butler

of this city (St. Helens) left here Wednesday for

Mount St. Helens. Tomorrow a second of division the company will start, consisting of Dr. J.H. McBride family, and Miss Treat, of Wawatoss, WI, who are visiting this place, Dr. Willis Morse, E.C. Giltner Miss Georgie



Giltner, of Salem, Mrs. N.E. Dolman, of St. Helens, and Dr. & Mrs. C.G. Caples, of Columbia City. The party will be reinforced from time to time by others who cannot go at present. They take with them sufficient supplies to last at least a month, and to judge from the preparations made a good time is sure to be the result. During their stay they expect to illuminate Mount St. Helens some night, of which announcement will be made later.
