WATER AND SEWER RATE ADJUSTMENT PUBLIC HEARING - JUNE 20, 2024, 6:00 PM

The Columbia City Council will hold a public hearing on June 20, 2024, at 6:00 pm to accept testimony about proposed adjustments to the current water and sewer rates. It is anticipated that the new rates will generate additional revenue equal to approximately 4% in sewer and 4% in water. If approved, the new rates will take effect on June 26 and show up on the July 26 bills. The additional revenue will help pay for operation and maintenance costs associated with the utility systems, make annual debt payments, meet loan debt coverage requirements, and complete necessary capital improvements as outlined in the water and wastewater system master plans.

A VIEW INTO THE PAST

Fred Lockley and his connection to Columbia City By Mark Stevens - <u>markstevens@colcomuseum.org</u>

About a year ago I became aware of a man named Fred Lockley. Fred was a newspaper columnist who wrote articles for the Oregon Journal. He was

also a very close friend of Fred Caples (the son of Charles Caples).

Fred traveled all over Oregon, usually staying overnight at the homes of people he met. Interested in their histories, he began writing about pioneers and pioneer life. In 1900, he mined gold in Nome



Alaska where he met Fred Caples who was also a miner there and they became lifelong friends.

In 1913 he became part of the editorial staff of the *Oregon Journal* and in 1919, he began writing the column, "Observations and Impressions of The Journal Man."

The following is an excerpt from one of his columns dated January 22, 1923 that pertains to Columbia City that I thought may be of interest to you.

"Recently I visited the Oregon State hospital. One feels mixed emotions in going through this tragic and wonderful institution." "The tragedy comes in knowing that so much of the ever-growing burden of Insanity is needless."

"After I had spent two afternoons with Dr. R. E. L. Steiner in visiting the various activities carried on there he called one of his assistants and said: "I have told Mr. Lockley that he can go wherever he pleases, talk to whomever he pleases and investigate this Institution, from the receiving ward to the ward for the criminal insane: so I am going to ask you to see that he is taken wherever he cares to go." What I saw on this trip furnished me sufficient material to make a score of articles, but I am going to mention only a few incidents of my tour of Investigation."

"I stopped to talk to a very interesting man in one of the wards and for 10 or 15 minutes he told me of the early history of Columbia County. He spoke of Fred Caples, an old-time friend of mine, whom he had known since Fred was a boy. He told me of the McBride's and many other old-timers and finally I said to my guide, "This man seems to be perfectly sane." My guide said. "Ask him about his money." I asked the old gentleman what he had done with his money. He said, "That is what is worrying me. I made a fortune in the racetrack. I also broke into the penitentiary some years ago and got all of their money. I stored it in a big chest in an old barn, not far from Columbia City. I am afraid the boys will discover it and steal it, for most of my wealth lay in 10-dollar and 20-dollar gold pieces, and the chest in so full it is apt to flow out and become scattered."

So I'll leave it to your imagination, was this man really crazy or is there a hoard of Gold coins in an old dilapidated barn somewhere outside of Columbia City? Has anyone else ever heard of this story? The man's name was not given in the article so a little more research is still needed to discover his identity.



CHIEF'S CORNER

Leashing your dog. With the nicer weather and

more frequent walkers, we just want to remind our citizens that we do have a leash requirement here in Columbia City. This requires each person who is walking a dog to have that dog always leashed unless



you are inside the dog park. This would also apply to when you are using Pixie Park and Trestle Beach. Keep in mind that you know your dog and it may be friendly as can be, but a person who does not know your dog can be traumatized by having your pet run up to them not knowing what to expect when it rapidly approaches them. If you would like to review the City Ordinance, go to <u>www.columbiacity.org</u>. Under Your Government, you will find City Ordinances and Charter, Chapter 4 – Offenses 4-2 Animal Control Ordinance No. 387, Sec. 1. 2. and Section 3. 1. outlines the requirement for animals to be leashed.

The Police Department serviced the following calls during March 2024: 1 abandon vehicle, 1 audible alarm, 2 animal complaints, 1 assist agency, 7 assist persons, 3 behavioral health, 1 civil call, 1 civil enforcement, 1 criminal mischief in progress, 1 death investigation, 1 DHS referral, 4 follow ups, 2 harassment/threats, 2 hazard calls, 1 incomplete 911 call, 2 juvenile problems, 1 minor in possession of alcohol/drugs, 2 motorist assists, 2 ordinance violations, 4 parking complaints, 88 premise checks, 1 found/lost property, 1 promiscuous shooting, 2 prowlers, 4 suspicious circumstances, 1 suspicious person, 2 suspicious vehicles, 1 traffic crash non-injury, 2 traffic complaints, 1 trespass, 13 traffic stops, 1 violation of restraining order and 1 welfare check. In all the Police Department serviced 172 activities.
